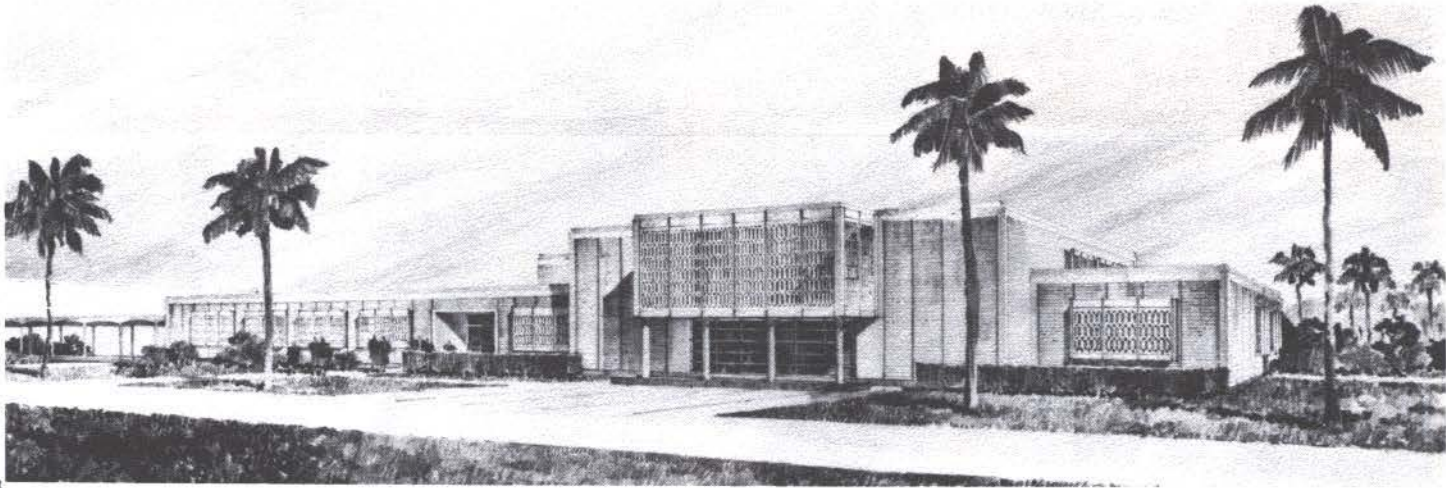




LIBRARY FUND DRIVE ANNOUNCED

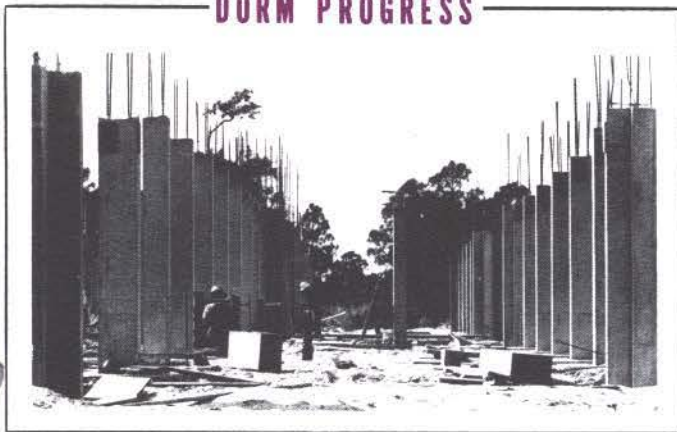


Highest priority in the College's building program has been assigned to the new Library by the Trustees-Regents. Approximate cost of this facility is \$750,000. Efforts are already underway to secure a half million dollars from private sources. This amount must be assured for the college to qualify for a \$250,000 Federal grant under Title I of the Higher Education Facilities Act.

Construction of the Library will increase space availability from 2,700 sq. ft., now temporarily used for this purpose in Founder's Hall, to 11,270 sq. ft. This will enable the college to increase its present holdings of 12,000 volumes to over 50,000 volumes; establish an audio-visual center; and provide a language laboratory.

Sister de la Croix has received a \$5,000 gift from Robert J. Quinn of Manhasset, N. Y., which is the first contribution to the Library Fund. Mr. Quinn's daughter, Nancy, is a graduate of the college.

ANNUAL SUSTAINING FOUNDATION

GOAL: 250 GIVING 250

At the request of the Trustees, the Board of Regents has undertaken a program to establish a Sustaining Foundation to provide a source of annual support for unrestricted purposes to meet the college's current needs.

Membership in the Foundation is open to corporate or individual contributors making a gift to the college of \$250 annually. In his presentation of this proposal, Chairman Patton emphasized such a gift is equivalent to interest

earned on an endowment of \$5,000 returning 5% annually.

One hundred members contributing \$25,000 is the equivalent of a half million endowment. Two hundred and fifty contributors giving \$62,500 is the equivalent of a 5% return on a million and a quarter endowment. The college has no endowment presently, except that which is credited to the contributed services of the Sisters.
